#### 5.0 REPORT FROM THE DEAN TO THE FACULTY - DR. D. KELLEHER

• Dean Kelleher outlined the report from the Dean, which was circulated in full.

#### 6.0 STRATEGIC PLAN UPDATE – DR. D. KELLEHER

- Dean Kelleher presented the Strategic Plan Implementation Update, as circulated.
- The new strategic plan builds on the Faculty's vision and values, reaffirming the fundamental premise of social accountability and introducing a new and complementary contract with ourselves. This new contract speaks to the individual and collective commitment to transform the organizational culture through behaviour and the way individuals treat one another.
- The presentation highlighted key areas of early progress within each pillar which include:
  - o Education:
    - Making significant progress on enhancing program accessibility, inclusion and support services available to learners who identify as members of underrepresented groups;
    - Developing a high-level implementation plan to build on successes across programs to increase enrollment and improve inclusion and support services;
    - Ensuring that the program offerings continue to prepare learners for evolving societal and career requirements.
  - o Research:

- Launching the Academy of Translational Medicine (ATM) to accelerate translation, and the Faculty will continue to develop the ATM over the coming years;
- Collaborating with partners to identify improvements to the health data landscape in BC and will build on lessons learned through the Covid experience to identify concrete improvements that can be made;
- Currently in the early stages of work with the he Office of the Vice-President, Research and Innovation, other universities, health partners, and industry to develop a bioinnovation hub proposal that will significantly increase the Faculty's research impact as part of the federal government's bio-manufacturing and life sciences strategy.
- Organization:
  - Launching the Transforming Culture Initiative and community-wide It Starts with Us series, which will continue to be a key priority, aiming to enhance inclusiveness, respectfulness, and support for all members of the Faculty of Medicine community;
  - Launching a new Faculty Emerging Leaders Program to develop a diverse group of new and aspiring faculty leaders;
  - Refreshing the approach to the Faculty of Medicine recognition awards and creating new awards and recognition opportunities.
- o Partnership:
  - Finalizing and launching the Faculty of Medicines' response to the Truth and Reconciliation Commission's Calls to Action, including a formal apology;
  - Hiring an Indigenous Initiatives Advisor and completing the recruitment process for a Director, Indigenous Engagement, both of whom will contribute to achieving health equity;
  - Collaborating with partners to build the bio-innovation hub concept, as noted in the Research Pillar.
- Additionally, pillar leads are now working to identify priorities in each pillar and will establish working groups for those priority areas. A call for volunteers to participate in working groups for specific projects that advance the strategic plan will be circulated and everyone is encouraged to volunteer.

# 7.0 PARTNERSHIPS AND HEALTH ENGAGEMENT UPDATE – DR. M. ALLARD & DR. J. PAWLOVICH

- Dr. Mike Allard, Vice-Dean, Health Engagement, presented the UBC Faculty of Medicine response to the Truth and Reconciliation Commission of Canada's Calls to Action.
- The Faculty of Medicine's response to the Commission included commitments to bring about meaningful, long-lasting change, include:
  - Enhancing recruitment and admissions processes to more effectively attract Indigenous students across all programs;
  - Addressing demographic imbalances in the Faculty;
  - Embedding an appreciation of Indigenous ways of knowing and healing in curricula;
  - Helping develop educational and health care systems that are accessible, equitable, effective, culturally safe, and free of Indigenous-specific racism and discrimination.

• Dr. John Pawlovich, Clinical Professor and UBC Chair in Rural Health, presented the Drone Transport Initiative Project. The initiative aims to test the feasibility of enhancing access to physically necessary goods (such as health care service supplies) using autonomous drone technology in north and central areas of British Columbia.

- The Northern Centre for Clinical Research is a partnership between the University of Northern British Columbia, the University of British Columbia Northern Medical Program and Northern Health. The centre will aid in the development of clinical research and provide a home for life sciences research in the North. The structure and governance of the centre was presented along with the impacts and goals of the centre which include:
  - Creating collaborative space for researchers interested in both clinical and life sciences in the north;
  - Conducting clinical trials at a distance, which will allow the recruitment of patients across the north;
  - Providing infrastructure and support for researchers in the clinical environment as well as workshops, seminars, general clubs and training opportunities;
  - Embedding the culture of research in health care delivery in the north.

- The Centre for Cardiovascular Innovation is a Vancouver Coastal Health Research Institute centre and has been building and developing cardiovascular research across the province. The centre's mission is to lead both nationally and internationally in cardiovascular research by providing the infrastructure to support and enhance the research capacity of its member investigators. An overview of the centre, which included topics such as collaborators, funding and organizational structure, was presented.
